### **Sheriff's Office & Local Agencies Arrest 36 in Warrant Roundup Operation February 17, 2010**

Sheriff Keith Nygren announced today the arrest of 36 individuals wanted for outstanding arrest warrants from McHenry and Lake Counties. The 36 arrests were the result of a one day arrest warrant roundup led by the McHenry County Sheriff's Office Apprehension Unit.

In an effort to address the large number of outstanding arrest warrants in McHenry County, various police agencies worked together to effect these arrests. Sheriff's deputies along with officers from the Illinois State Police, McHenry Police Department, Cary Police Department, Crystal Lake Police Department, Huntley Police Department, Island Lake Police Department, Woodstock Police Department, Harvard Police Department, Lake County Sheriff's Office, and deputies from United States Marshal Service participated in the arrest warrant roundup.

The arrest warrant roundup began in the early morning hours of February 17, 2010 and ended around 11:00 A.M. The arrest warrants served were for felony and misdemeanor crimes. Many of these arrest warrants were served upon repeat offenders and those who had multiple warrants for their arrest. The success of this operation is credited to the numerous police agencies involved and their cooperation.
